II.Housekeeping

- A. Credentials Committee Report was presented by Committee Chair Cyndi Newburn. Quorum is present. As of today there are 219 District 3 Clubs in good standing, each with two eligible voting members for a total of 438 delegates. District bylaws require quorum or 1/3 or 146. There are 181 represented, plus additional 41 members of the District Executive Committee for a total of 222 votes.
- B. Unanimous Consent On occasion, the chair will use the procedure called "unanimous consent" to expedite business not considered controversial. We heard the phrase "without objection" or "if there is no objection" in each case. If a member wants the issue debated or voted on, we were instructed to call out "I object" or "objection."
- C. Membership The members of the District Council are: The club Presidents or their proxies; the club Vice Presidents of Education or their proxies; and the members of the District Executive Committee. Without objection, the chair of any District 3 standing committee or special committee or their sole representative and all past District Governors of any district will have privileges of the floor; that is, they may speak in debate but may not make, second or vote on motions.

- B. The proposed district realignment was first presented to the District Executive Committee (DEC) in March, after some decision the DEC voted to recommend the realignment to the District Council. The district realignment was presented by the realignment chair Nancy Goins, DTM. The following amendments were adopted.
